We have two mandatory online training courses that all employees are required to complete which cover Equal Employment Opportunity (EEO) and Bullying & Harassment in the workplace. New employees are required to complete these courses as part of their corporate induction. Existing employees are required to undertake refresher training at regular intervals.

Face to face sessions that specifically support gender equality will continue to occur with managers with regards to updates in legislation.

Our 'new appointments' and 'promotions' tracking mechanisms have drastically improved in the past 12 months compared with previous years as both our recruitment systems and internal processes have been updated to support clearer tracking and reporting. Based on our updated processes and various internal re-structures within the business, this years figures provided in 1.10, 1.11 and 1.12 are higher than the previous reporting period but are accurate for this reporting period.

All staff have access to our Employee Assistance Program (EAP) through Prima Careers, whereby the company approves 3 paid sessions for employees with a psychologist.
 We also offer staff (on a case by case basis) the option to work from home and/or flexible start/finish times for employees who have caring responsibilities. These options are available for discussion at both our head office and work site locations.
 Any staff who are on maternity leave at the time of our annual remuneration review are still awarded a remuneration increase (based on merit) so they don't fall behind. We also always will backfill a maternity leave position as a fixed term contract.
 We also offer 'keeping in touch' days to staff who are on maternity leave and ensure they are contacted regarding any big news/changes etc that are occurring within business while they are on leave.
